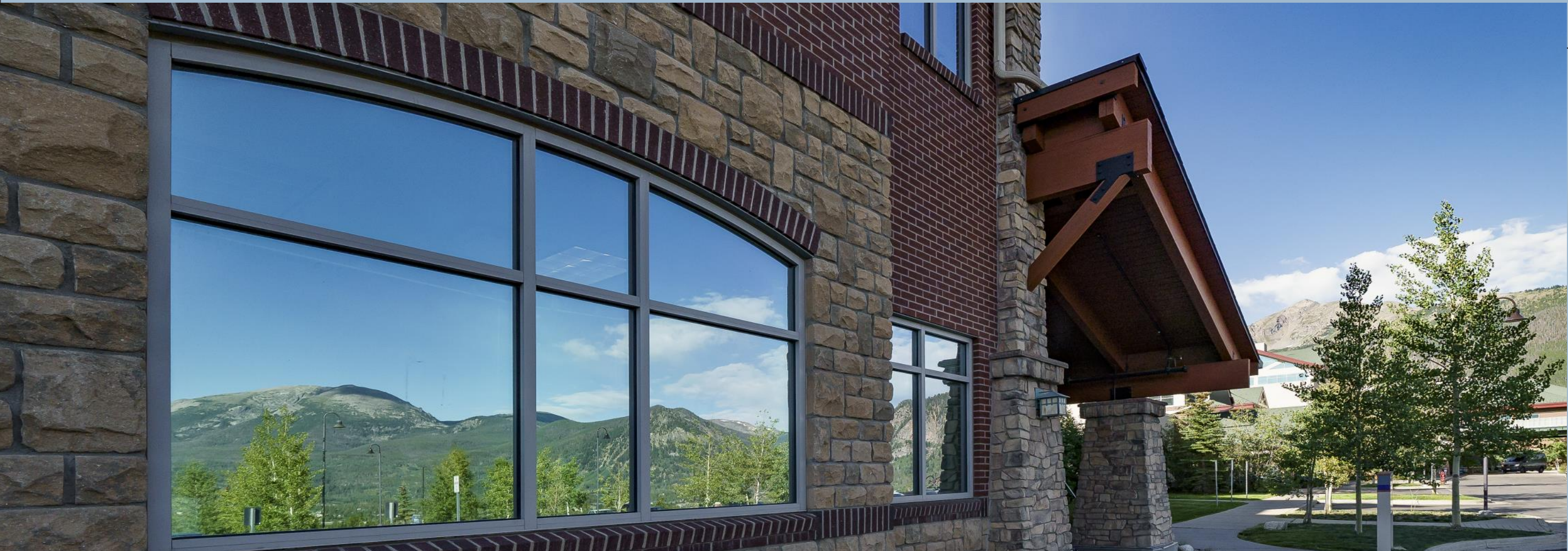
DONATIONS: Cash, check, credit card or stock contributions can be made at any time to support general operating or designated funds.

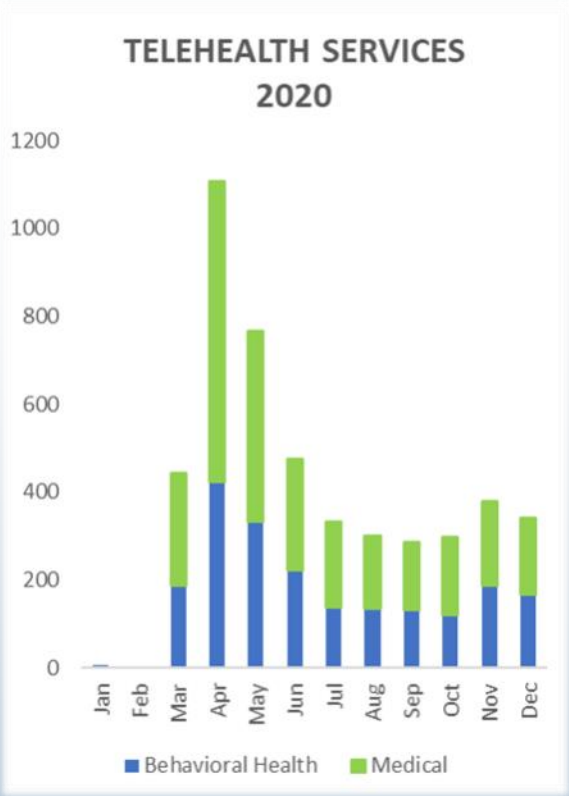
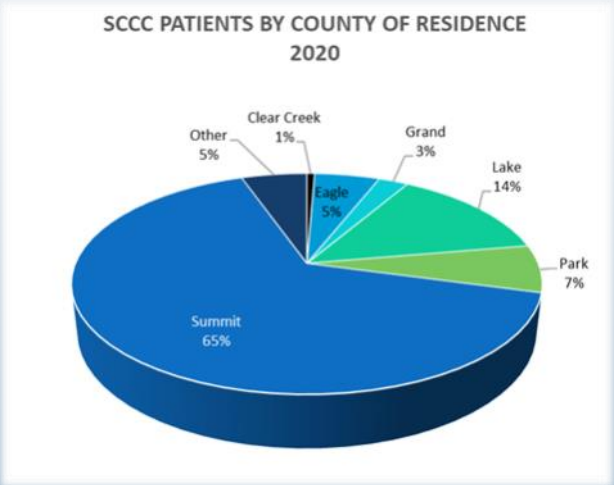
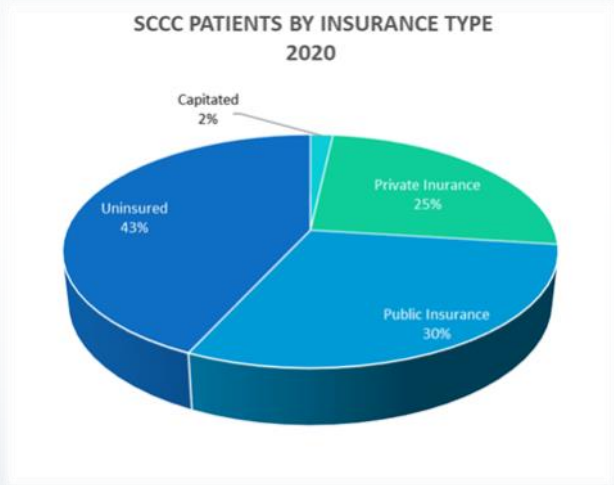


Team Based Care engages Medical, Dental and Behavioral Health providers and support staff to provide the highest quality, coordinated health services.

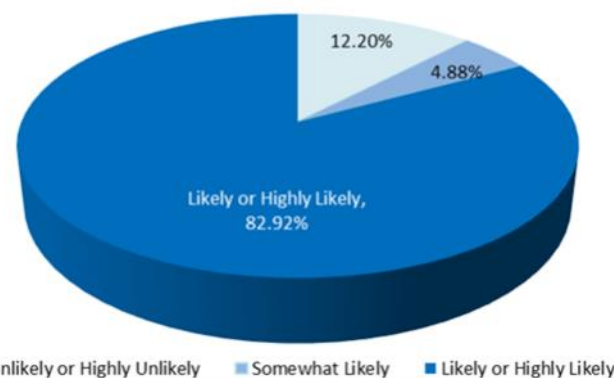

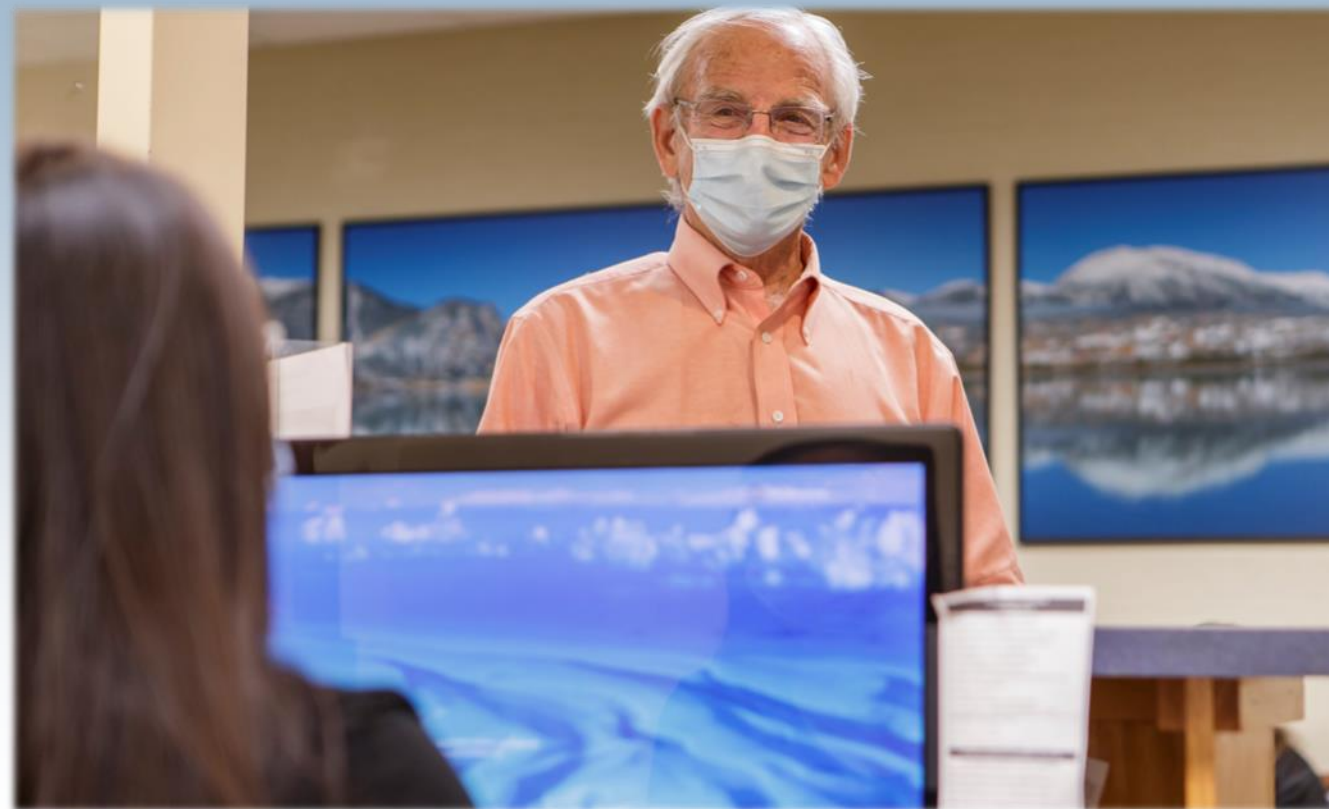
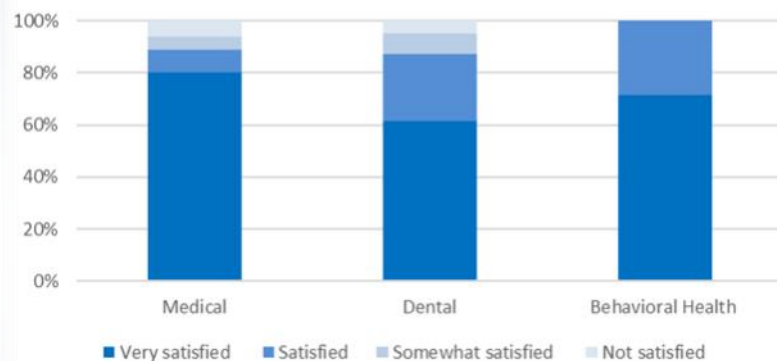


How likely are you to recommend the Care Clinic to family or friends?

How satisfied were you with the care you received from your provider?

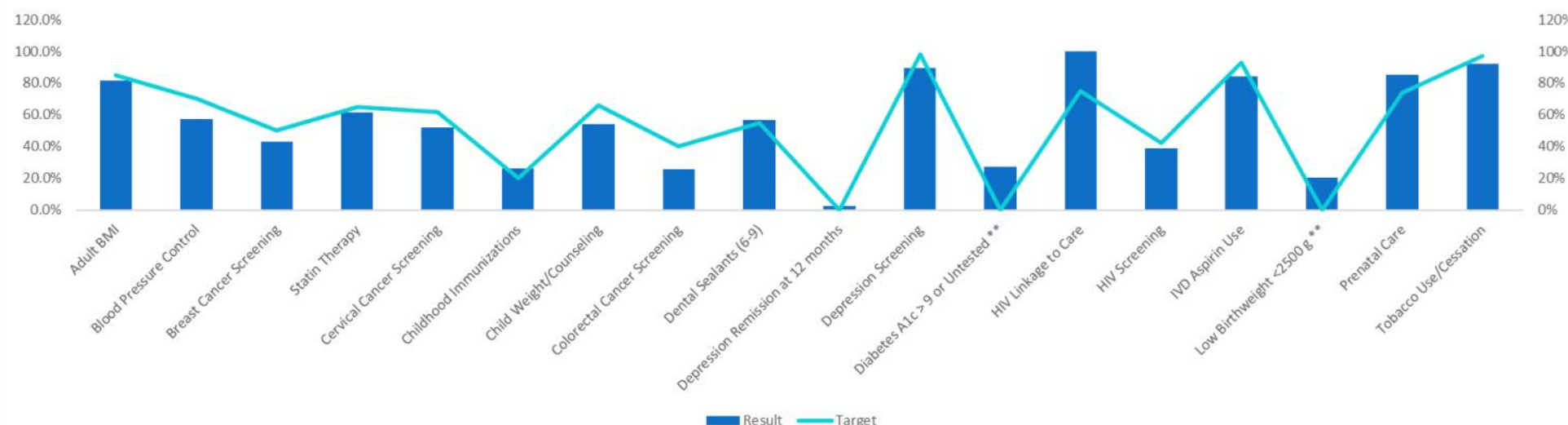


The Care Clinic exceeds state and national benchmarks on many of its Uniform Data Set (UDS) measures and is proud to have kept its performance high in key areas during the pandemic. Notable areas of success include measures related to Low Birth Weight, Prenatal Care, HIV Linkage to Care, and Diabetes.

Patient satisfaction remains high with almost 83% of patients highly likely or likely to refer friends or family for services.

In 2020, the Care Clinic received recognition from the US Health Resources and Services Administration for its work as a Level 3 (the highest level) Patient Centered Medical Home (PCMH) and for Advancing Health Information Technology (HIT) to improve quality.

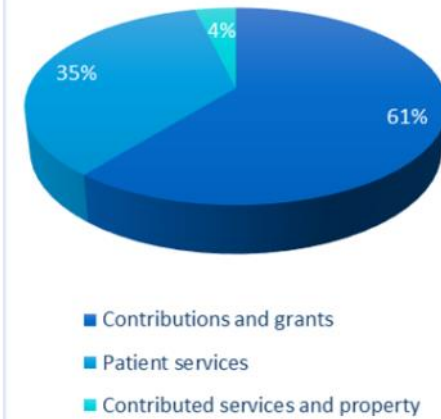

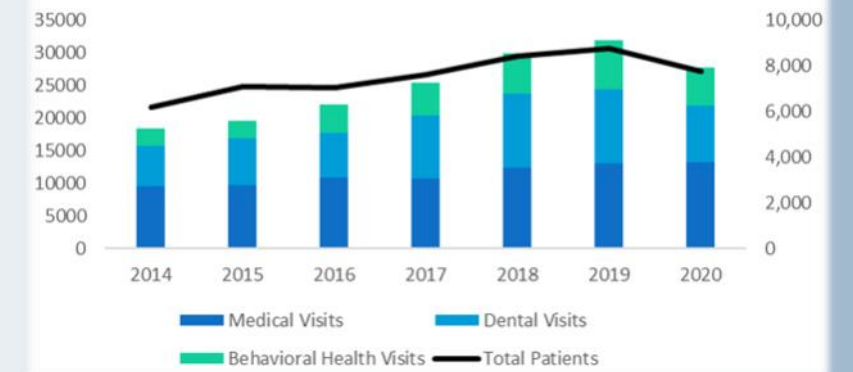

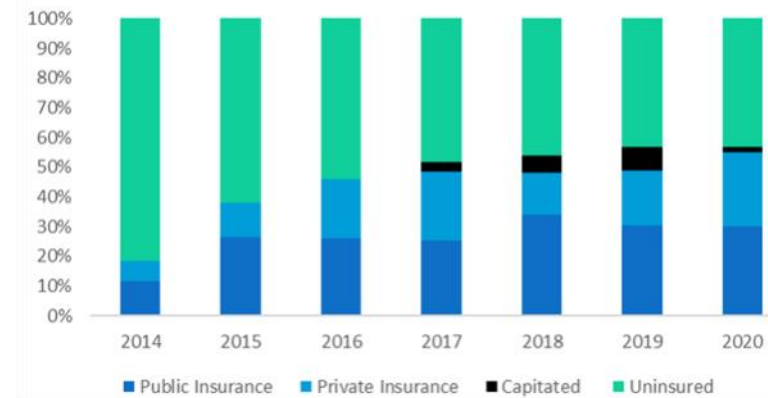
2020 SOURCES OF REVENUE



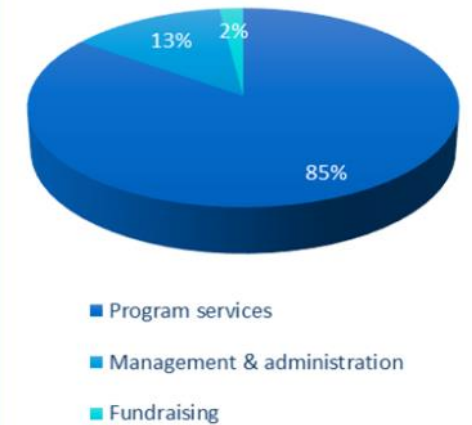
SCCC TOTAL PATIENTS AND VISITS BY SERVICE LINE 2014-2020

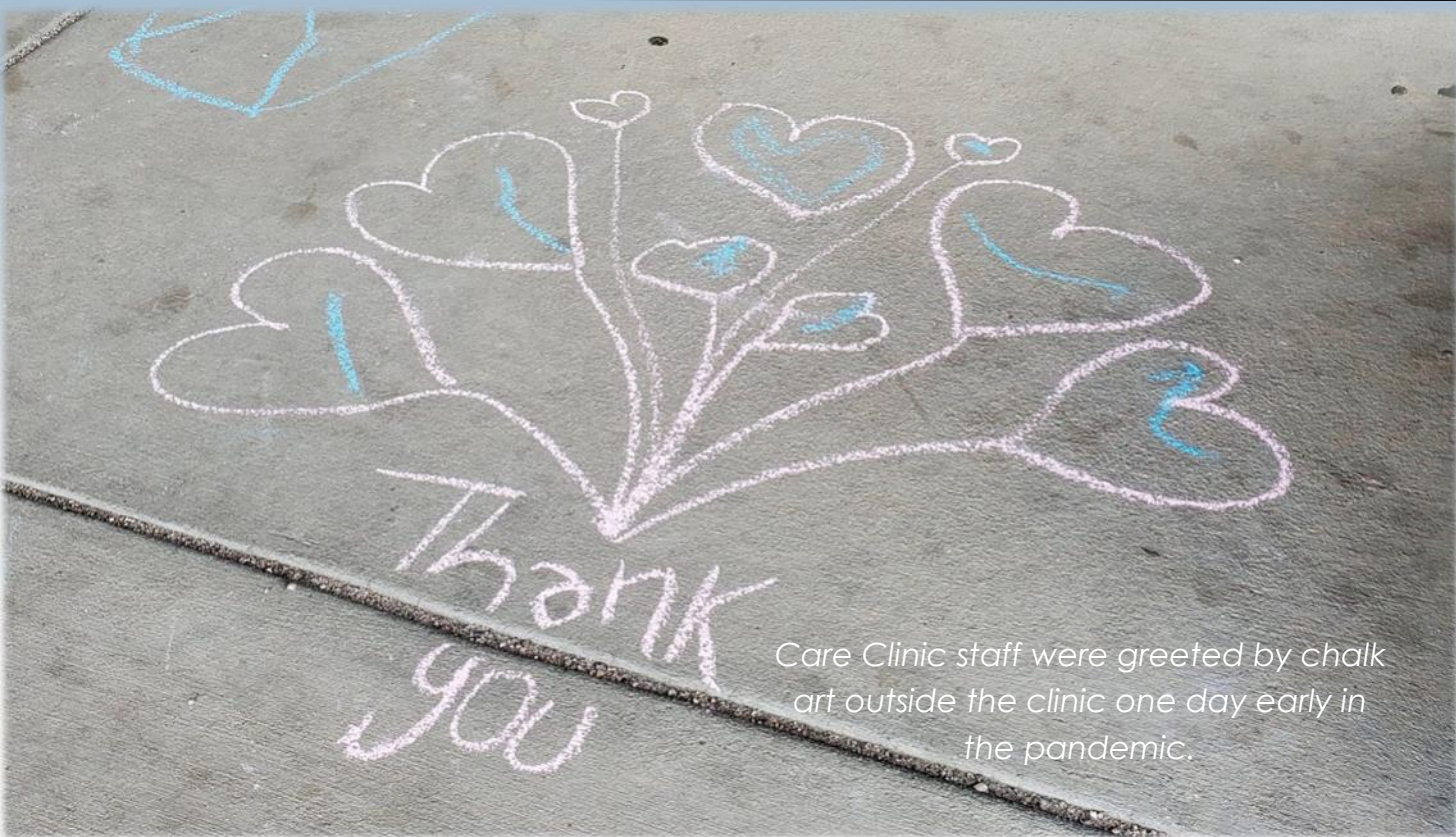
